Risk Statement

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By allowing the child named in this form to participate in this event I, the parent/guardian of the child, agree and acknowledge that:

- a) I am aware of the inherent element of risk involved in the sport of sailing and accept responsibility for exposing my child to such inherent risks;
- b) I have satisfied myself that the child named has the necessary skill and knowledge to participate in the event and to deal with conditions that may arise whilst afloat and ashore during this event;
- c) I will not allow the child named to participate in the event whilst they are under the undue influence of alcohol, drugs or whilst otherwise unfit to participate;

- d) I am responsible for ensuring that, if providing a privately owned boat that the boat is in good order, equipped as required in the event Notice of Race (NoR) and insured, including third party liability insurance of the equivalent of at least £3 million GBP;
- e) I am responsible for the aforementioned child's property whether afloat or ashore;
- f) I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of the child;
- g) the provision of a race management team, support boats and other officials and volunteers does not relieve me of my parental/guardianship responsibilities or the child of his/her responsibilities;
- h) it is my responsibility to familiarise myself and the child with any risks specific to this venue or this event drawn to our attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event;
- i) the provision of support boat cover is limited to such assistance, particularly in extreme / inclement weather conditions, as can be practically provided in the circumstances.
